The conduct at issue herein took place on or about the 2022 volleyball season and is ongoing. During the school year and volleyball sports season, Mr. Petersen and Mr. Petersen's child were uncomfortable with the behavior of one of the middle school coach volunteers. Mr. Petersen's child was inappropriately touched (along with other atheletes), present when Samuel Sandle flirted with other coaches, and otherwise made to feel uncomfortable by Samuel Sandel through the portion of the season Mr. Petersen's child participated. Multiple parents sent letters of complaint and notified the school district or its agents of the inappropriate conduct. In September 2022, Mark Fisk informed Mr. Petersen that Mr. Sandel was staying on as a volunteer. Dissatisfied, Mr. Petersen retained an attorney who reported that based upon his investigation he believed Samuel Sandel has a violent criminal history including at least one active warrant and prior felony.

Because Mr. Petersen believed that Mr. Sandel's substantial criminal history was disqualifing and school policy required that the school district decline Mr. Sandel's offer to volunteer, Mr. Petersen filed complaints with the middle school, superintendent, school board, state board of education and provided the information to police. Boundary County School District and the middle school rely upon SRO Brandon Johnson and the Bonners Ferry Police Department to conduct criminal background checks on volunteers. The superintendent presented the information that Mr. Petersen discovered regarding Mr. Sandel to the Board who discarded the policies and approved Mr. Sandel despite the superindentent recommending that Samuel Sandel not be approved as a volunteer.
