It was not a job that I had ever really considered doing but once I began working for the BFPD my eyes were opened to a whole new world.

While at the Boundary County Sheriff's Office I worked as a Patrol Deputy before obtaining the position of Detective in 2021 where I served in that capacity until stepping aside to focus on my family and business in August of 2022.

I have been involved with many different programs in our community to include youth wrestling and middle school wrestling. I am currently coaching at the High School level for the Bonners Ferry Badgers.

I was a Hunters Education Instructor from 2015 until 2022.

I am currently a member of the Sheriff's Office Dive Team. I am a Level One Reserve Patrol Deputy for the Boundary County Sheriff's Office, where I assist both the Patrol and Detention divisions, as needed.

I am lucky enough to live on a farm where my children raise 4H animals and we have horses which I enjoy riding and hunting off of. In my opinion there is no better way to relax than to explore our county on the back of a horse.

I am also a hay farmer growing grass and grass/alfalfa hay on the north bench.

While away from the everyday hustle of working for the Sheriff's Office I have had time to contemplate the next chapter of my life and "take a look around." During these past few months, it has become very clear to me that we need to come together as a community. I care about what happens in our community so with the encouragement of others and the support of my family, I have decided to put my hat in the ring and run for Sheriff
